

## Pre requisites/ Eligibility Terms and Conditions for various posts

- 1. Eligible candidates are required to go through the particulars of notification carefully, fill up the application completely and submit online (Website).
- Applicants must have the fee payment details like UPI reference no. Same should be mentioned in the particular column of the online application (Use QR code mentioned in the online application). For inaccurate payment details or if payment is not effected such applications will not be accepted.
- 3. Last date for submission of application is 19th April, 2024.
- Payment fee of Rs. 500/- (Inclusive of GST) shall be made by way of UPI only. (UPI QR code is enclosed in the google form).
- 5. Soon after submission of application online, the applicants will receive the details of the successful submission to their respective e-mail ID furnished in the application.
- 6. Examination will be online conducted at Hosapete (Vijayanagara Dist.) Candidates shall attend through the Smartphone/Tab etc. with sufficient data and battery backup.
